2024 NOP Program Handbook Update

Stakeholder Reference Document

The Agricultural Marketing Service (AMS) has published an updated version of the <u>National Organic Program</u> (<u>NOP</u>) <u>Handbook</u>. This public resource provides USDA-accredited certifiers and certified organic operations with guidance, instructions, and other policy documents that can help them comply with the USDA organic regulations. Several previous NOP Handbook documents have been archived because they have been replaced by new regulations, such as the Strengthening Organic Enforcement (SOE) rule. Other documents have been revised with minor edits to keep the content up to date with current regulations. In addition, USDA has relocated some general education resources from the Handbook to more relevant locations on NOP's website and in the Organic Integrity Learning Center.

This document summarizes the changes made to the Handbook in this 2024 update. Its purpose is to communicate clearly to stakeholders in the organic community what has changed, and to identify the new locations of relocated documents.
