Decisions Made (What, Why, Impacts)

- The FVIAC Chair recommended this meeting be used as an information gathering mechanism. No decisions were made regarding the development of USDA recommendations.
- The FVIAC membership body would need to determine which agricultural issues they plan to explore. FVIAC workgroups should be established prior to developing recommendations.

Discussion

- FVIAC representatives were provided one minute each to share comments of their preference.
- The representative body concurred with the FVIAC Chair's suggestion to decide which workgroup (subcommittee) using email communication and electronic surveys.
- FVIAC DFO provided insights on establishing focused subcommittees and ways the FVIAC can collaborate with other USDA advisory groups, which could help curtail the submission of duplicative or conflicting recommendations from USDA advisory groups that have common goals and objectives.
